WE understand with this epidemic, that most of us do not want to personally come in contact with anybody. That is why we have come up with this system. Please read how we can do this.

1. Download, Print and Fill out the Interview Sheet completely, sign it, and email it back to us.
2. Send us a selfie (picture of you holding your personal identification).
3. Send us either a picture or a PDF of all your Tax documents.
4. Call the office where you send these documents by e-mail to let them know you are asking for a consultation. They will talk with you and start preparing your tax return.
5. Once prepared, and agreed upon, we can send you your tax return, encrypted, through email. We cannot file your tax return without your consent. That is why you must send us back the 2848, Power Of Attorney to file your tax return.
6. You decide how you want to receive your tax refund, or pay the amount due. We suggest a direct deposit into your bank account if you have a refund. We can also print a check for you in our office.
7. You can pay our fees either by credit card over the phone, or, if you have a refund coming, we can take our fees out of your refund. It is your choice.

You are not required to complete this form to engage our tax return preparation services. If we obtain your signature on this form by conditioning our tax return preparation services on your consent, your consent will not be valid. Your consent is valid for the amount of time that you specify. If you do not specify the duration of your consent, your consent is valid for one year from the date of signature.

If you do not consent, then you may still have your tax return prepared and electronically filed by us for a fee.

For your convenience, we have entered into arrangements with third party affiliates to provide qualifying taxpayers with the opportunity to apply for financial products (Loan, Electronic Refund Check, or Electronic Refund Deposit). We have also entered into an arrangement with Versicom Communications to offer qualifying taxpayers ABCvoice Tax Infoline. To determine whether these products may be available to you, we will need to use your tax return information by analyzing it and calculating the amount of your anticipated refund.
