- 4. Call the office where you send these documents by e-mail to let them know you are asking for a consultation. They will talk with you and start preparing your tax return.
- 5. Once prepared, and agreed upon, we can send you your tax return, encrypted, through email. We cannot file your tax return without your consent. That is why you must send us back the 2848, Power Of Attorney to file your tax return.
- 6. You decide how you want to recive your tax refund, or pay the amount due. We suggest a direct deposit in to your bank account if you have a refund. We can also print a check for you in our office.
- 7. You can pay our fees either by credit card over the phone, or, if you have a refund coming, we can take our fees out of your refund. It is your choice.
